The information contained in this Account Application is true, complete and accurate and you agree to notify Cheung's Gold Traders Limited ("Cheung's") of any changes to that information. Cheung's is entitled to rely fully on such information and representations for all purposes, unless Cheung's receives notice in writing of any change. Cheung's is authorized at any time to contact anyone, including your banks, brokers or any credit agency, for the purpose of verifying the information provided on this Account Application. Attached copy of Cheung's Privacy Policy formed part of the Customer Agreement of Cheung's ("Customer Agreement"). I/We, the undersigned Client(s), have read and understood the clause within Cheung's Privacy Policy.

RISK DISCLOSURE STATEMENT 風險披露聲明

The risk of loss in gold bullion/silver trading can be substantial. You may sustain losses in excess of your initial margin funds. Placing contingency orders, such as "stop-loss" or "stop limit" orders, will not necessarily limit losses to the intended amounts. Market conditions may make it impossible to execute such orders. You may be called upon at short notice to deposit additional margin funds. If the required funds are not provided within the prescribed time, your position may be liquidated. You will remain liable for any resulting deficit in your account. You should therefore carefully consider whether such trading is suitable in light of your own financial position and investment objectives. (Please refer to "Customer Agreement").

黃金/白銀交易的虧損風險可以十分重大。閣下所蒙受的損失可能超過閣下的最初保證金款項,即使閣下定下備用交易指示,例如「止蝕」或「限價」交易指示,亦未必可以將虧損局限於閣下原先設想的數額。市場情況可能使這些交易指示無法執行。閣下可能被要求一接到通知即存入額外的保證金款額,如閣下未能在所訂的時間內提供所需的款額,閣下的未平倉合約可能會被平倉。閣下將要為閣下的賬戶所出現的任何逆差負責。因此,閣下必須仔細考慮,鑒於自己的財務狀況及投資目標,這種買賣是否適合閣下。(請參閱「客戶協議」)。
